In the application please state first and last name, place of work and position, indicate a need in a hotel, arrival and departure dates. Abstracts are to be sent to E-mail: istc@ukr.net. The deadline is February 19, 2017.

For presentation at the conference, it is recommended to prepare the presentational material (10 - 20 slides in MS Power Point). The program of presentations is formed by the organizing committee. Best reports will be recommended for publication in a journal “Economic bulletin of NTUU “KPI”.
